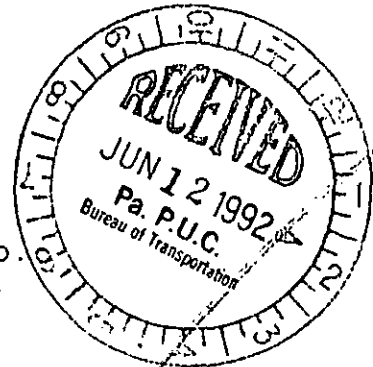

3. Applicant is a Delaware corporation which possesses a Certificate of Authority to do business in the Commonwealth of Pennsylvania. Exhibit "A" attached hereto and made a part hereof is a true and correct copy of Applicant's Certificate of Incorporation, as amended, as filed with the Secretary of the State of Delaware. Exhibit "B" attached hereto and made a part hereof is a true and correct copy of Applicant's Certificate of Authority to do business in the Commonwealth of Pennsylvania as filed with the Secretary of the Commonwealth.

4. Applicant designates Robert Kidwell, its Terminal Manager, at Independent Freightway, Inc., Route 655, Box 484, Reedsville, PA 17084 as the person upon whom service of any notice, process or order of your Commission may be made for it.

5. Applicant holds a Certificate of Public Convenience at A.00107087, and various folders and amendments thereunder, authorizing Applicant to transport as a Class D carrier certain property and in certain territory described in your Commission's Orders entered February 19, 1988, October 5, 1988 and August 2, 1991 authorizing the issuance of its Certificate of Public Convenience as amended. Applicant is presently providing such transportation service. The operating authority proposed by Applicant herein will supplement its existing operating authority.

6. Applicant also possesses operating authority in the transportation of property as a common carrier from the Interstate Commerce commission. The operating authority herein proposed will coordinate with Applicant's interstate operating authority.

7. Attached hereto as Exhibit "C" and made a part hereof are Applicant's internally prepared comparative balance

sheet as of December 31, 1989, 1990 and 1991 and also its comparative statement of income for the years then ended. Applicant's financial condition has not changed materially since December 31, 1991. Applicant continues to operate at a profit and is financially fit to provide the proposed service.

8. Applicant proposes to transport as a Class D carrier (i) manufactured pre-cast concrete units from the facilities of Beavertown Cast Stone, Inc. in the Township of Franklin, Snyder County, Pennsylvania to points in Pennsylvania and return, (ii) industrial water treatment chemicals from the facilities of Betz Laboratories, Inc. in the Township of Middletown, Bucks County to points in Pennsylvania and return, (iii) feed grade pre-mixes for livestock in bags, not in bulk, from the facilities of Precise Agri-Products, Inc. in the Borough of Middle Creek, Snyder County to points in Pennsylvania and return, and (iv) vitamins and minerals in bags, not in bulk, from points in the Borough of Braddock, Allegheny County and the Borough of Lititz, Lancaster County to the facilities of Precise Agri-Products, Inc. in the Borough of Middle Creek, Snyder County.

9. As rates for the proposed service, Applicant proposes to charge the rates which are established in tariffs

on file with your Commission as supplemented from time to time according to law.

10. Applicant is not now engaged in any intrastate transportation of persons or property for compensation in Pennsylvania except as authorized by the Certificate of Public Convenience as amended, which is issued to Applicant by your Commission

11. The service proposed to be rendered by Applicant is necessary or proper for the service, accommodation or convenience of the public for the following reasons:

(a) Applicant is experienced in rendering to the public common carrier service for the transportation of property by motor vehicle;


(b) The proposed service will serve a useful public purpose, responsive to a public demand or need.
