My bathroom walls are cracking and they all will have to be repaired. They installed

A Whole House Fan in the bathroom and that was to take care of the dampness.

If so it should take care of it. The fan seems to blow dust on everything in the bathroom.

Also the back Bedroom was my warmest room in the house now it is the coldest and

Is very humid and I am not able to sleep there. All the rooms are a different Temperature and I feel this should not be. The bed sheets are even damp. Also when the power vented gas water heater was installed they didn't install An outlet for it to be plugged into so you can't wash and dry clothes at the same time. I am a widow and have health issues and I thought it would be a good thing to have The work done by the Columbia Gas Company but it seems it came back and bites me In the butt.
