I also request a waiver of the \$350 application fee since this is change is only administrative in nature.

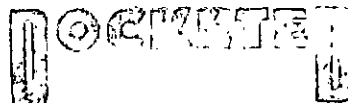

§ 1.36. Verification.

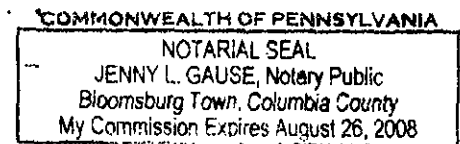
