

**PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)**

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file a Notice of Intervention in proceedings before the Commission filed by Martin P. Baronner against Pennsylvania Electric Company (Penelec) at Docket No. C-2014-2404307.

In his Formal Complaint, Mr. Baronner, along with the Utility Workers of America System Local 102, allege “serious, repeated, and apparently willful violations” of Commission regulations regarding the reading of residential meters by Penelec. Specifically, the Complainants allege that Penelec violates Commission regulations requiring a utility that bills consumers monthly to read residential meters at least once every two months, absent certain exceptions.

The Consumer Advocate has filed this Notice of Intervention with the Commission to ensure that Penelec adheres to reasonable meter reading and billing procedures as required by the Commission’s regulations. The Office of Consumer Advocate seeks to ensure that safe and reliable service is provided to all consumers at just and reasonable rates and in accordance with the consumer protections contained in the applicable statutes and regulations.
