You are being granted an initial thirty (30) days in which to file the verified statement. The statement is due on or before November 17, 1988.

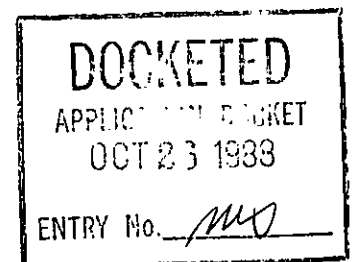
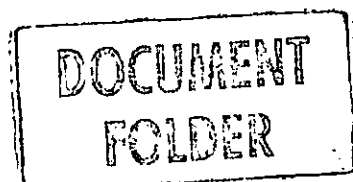
If additional time is required, it may be requested by telephone but should be followed in writing with the reasons for the extension stated.

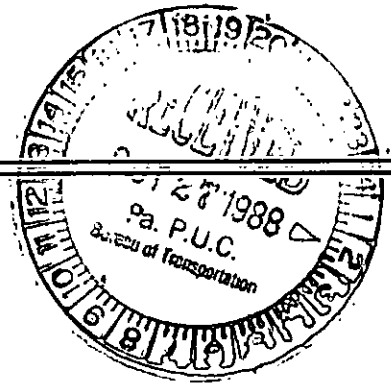

The following is a verified statement in support of my application for issuance of a Contract Carrier Permit, and states as follows:

1. My legal name is Robert Molnar, t/d/b/a Robert Molnar Hauling. I reside in Sutersville, Westmoreland County, Pennsylvania. My mailing address is R.D.#1, Box 38A, Sutersville, PA. 15083.

2. This verified statement is being made by Robert Molnar, an individual over the age of 21 years, who trades and does business as Robert Molnar Hauling, for the past fourteen years.

3. I am not affiliated with any other common carriers or parties who have been issued a Permit as a Contract Carrier by the Pennsylvania Public Utility Commission.

4. "-contract carrier- coal, for Amerikohl Mining, Inc., between points in the county of Westmoreland, and from points in said, county, to points within an airline distance of seventy-five (75) statute miles of the limits of said county, and vice-versa."

5. I am not currently hauling under my operating rights, due to the fact that Mikel Coal Company, is temporally shut down.

6. I have no knowledge or information which would lead me to believe that the issuance of a permit to me as a Contract Carrier authorizing me to undertake the fulfillment of my contract with

Amerikohl Mining, Inc., would result in the duplication of any authority authorized to me or any third party by the PUC.

7. I have no knowledge or information which would lead me to believe that the issuance of a permit to me as a Contract Carrier, authorizing me to undertake the fulfillment of contract with Amerikohl Mining, Inc., would result in dual operations by myself or a third party resulting from a grant of authority by the PUC.

8. The base of my operation is R.D.#1, Box 38A, Sutersville, PA. This is in Westmoreland County. Communication is maintained through Citizens Band Radios in each truck, and mobile phones in a few.

My safety program includes the maintenance of a fire extinguisher and flares on each truck and requiring each driver to wear a hard hat and safety shoes, and to comply with the requirements of the Department of Transportation of the Commonwealth of Pennsylvania and the health and safety requirements of the Occupational Safety and Health Administration and the Mine Safety and Health Administration of the United States Department of Labor, as applied to our operation.

11. I will haul coal from various plants and surface mining operations in Westmoreland County to various coal processing and loading facilities for Amerikohl Mining, Inc..


