Dear Harold E. Trego, Inc.:


This is to acknowledge receipt of your letter dated April 10, 1984, in which reinstatement of your cancelled certificate is requested.

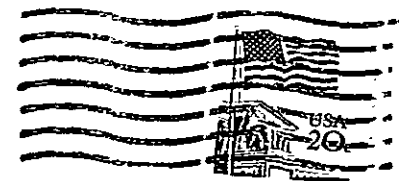
