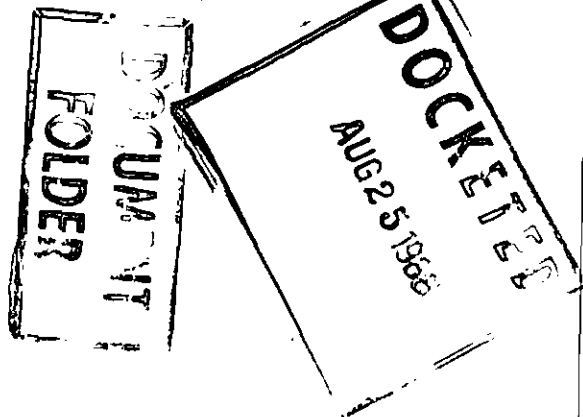
ORDER CANCELLING CERTIFICATE

BY THE COMMISSION:

At its Public Meeting held May 26, 1988 the Commission adopted an order directing the above-named respondent to show cause why its certificate of public convenience should not be cancelled. Our order directed that an answer be filed within twenty (20) days and that, in the absence of any filing, the averments in the order would be admitted.


