
To Whom It May Concern:

On May 30 and August 31, 1995, the Commission sent billings to your company for your assessment for our 1995-96 fiscal year. You have made no payment on the total assessment of \$5,932.00.

You are directed to pay the outstanding amount of your assessment by January 5, 1996. Your check or money order, payable to the Commonwealth of Pennsylvania, should be forwarded to Carmon Bass, Pennsylvania Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265. Failure to make timely payment will result in the institution of an action to cancel your certificate of public convenience.

In the event that your certificate is cancelled, additional action will follow. Pursuant to 66 Pa. C.S.A. §510(c), we may request the Pennsylvania Department of Transportation to revoke the vehicle registrations of all your motor vehicles licensed in Pennsylvania. Also, we will notify the Pennsylvania Department of Revenue that you are no longer eligible for sales and use tax exemption as a common carrier under our jurisdiction. Finally, we will notify your insurance carrier that your company cannot lawfully provide service within this Commonwealth.

Dear Sir or Madam:

As of the date of this letter, the above utility has an outstanding balance of \$2,627.00 in assessment fees. These assessment fees are now overdue.

Pursuant to Section 510 of the Public Utility Code, 66 Pa. C.S. Section 510, a certificated public utility is **required** to pay its assessment within the period established by the Commission, even if a timely objection has been filed. If, after hearing, the Commission determines that the assessment was excessive, erroneous, unlawful or invalid, the Commission will make an appropriate refund of the amounts found to be excessive, erroneous, unlawful or invalid. Failure to pay this assessment is a violation of the Public Utility Code and will subject you to legal action by this Commission including, but not limited to, the imposition of a civil penalty of one thousand dollars (\$1,000.00) per day for a continuing violation of the Public Utility Code.

You are required to pay the overdue assessment bill within twenty (20) days of your receipt of this letter. If you fail to pay your assessment with twenty (20) days, the Commission will institute appropriate legal action against you.
