NOTICE OF SUSPENSION

This is to notify you that effective as of the above date your Certificate of Public Convenience is suspended because of your failure to have filed with this Commission a Certificate of Cargo Liability Insurance to replace cancelled insurance.

If evidence of insurance coverage is not received by the Commission within twenty (20) days, a recommendation that a complaint be instituted against you for failure to comply with the insurance requirements will be presented to the Commission.

If, as a result of this complaint, your Certificate of Public Convenience is cancelled, the Commission will not consider a request for reinstatement. A carrier who has forfeited his rights through failure to comply with insurance requirements and who desires to regain his rights must file a new application accompanied by the filing fee of \$10.00. This application will follow the usual procedure and may, at the Commission's discretion, be set down for formal hearing.

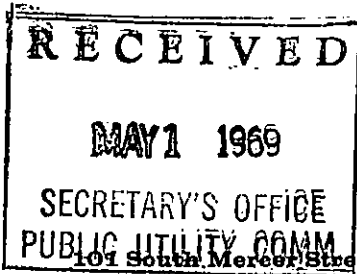

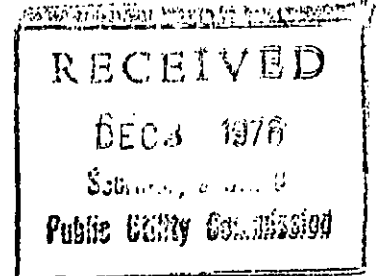

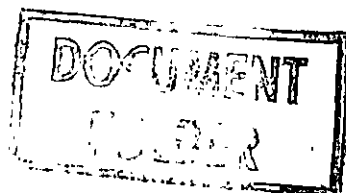

GOVERNING THE
TRANSPORTATION OF

As a Class D Carrier, building materials between points in the Counties of Lawrence, Butler, Beaver and Mercer, provided no haul shall exceed a distance of twenty-five (25) miles from point of origin to point of construction;

As a Class D Carrier, brick and lime such as are usually transported in dump trucks between points in the County of Lawrence;

As a Class D Carrier, brick and lime such as are usually transported in dump trucks from points in the County of Lawrence to job sites and point of construction or disposal in the Counties of Butler, Beaver, Mercer and Allegheny, provided no haul shall exceed a distance of sixty (60) miles from point of origin to point of construction or disposal;

As a Class D Carrier, brick and tile for the Metropolitan Paving Brick Company and the Pearson Brick Company, from points in the County of Lawrence to job sites and points of construction located within an airline distance of one hundred fifty (150) miles of the limits of the said county;

As a Class D Carrier, clay products and shale products, used in building construction, from points in the County of Beaver to job sites and points of construction in Pennsylvania, excluding the County of Allegheny, and the return of pallets to the point of origin;

As a Class D Carrier, clay products, and shale products, used in building construction, from the plant of Fenati Brick Company, Inc. in the County of Lawrence to job sites and points of construction in Pennsylvania, and the return of pallets to the point of origin;

As a Class D Carrier, shale products and clay, for American Fire Clay and Products Company, from its plant in the Township of Mahoning, Lawrence County, to job sites in the County of Lawrence and to other points in Pennsylvania, and the return of pallets to the point of origin.
