Enclosed for filing on behalf of PPL Electric Utilities Corporation ("PPL Electric") is PPL Electric's Calculation of the Phase 1 Act 129 Compliance Rider ("ACR 1") for the Application Period of June 1, 2014 through May 31, 2015. This calculation report, which is being filed pursuant to the procedures set forth in PPL Electric's Tariff - Electric Pa. P.U.C. No. 201, reflects actual data through March 31, 2014.

The ACR-1 residential rate was set to \$0.000 effective March 20, 2014 (Secretarial letter, Docket No. M-2014-24-09366 and M-2014-2409569). The remaining balance as of March 31, 2014 is being transferred to ACR-2 and included in the June 1, 2014 rate calculation.

The ACR-1 Small C&I is proposed to be set to \$0.00, effective June 1, 2014. The remaining under collected balance will be transferred to ACR-2 and be included in the June 1, 2014 rate calculation.

Pursuant to 52 Pa. Code § 1.11, the enclosed document is to be deemed filed on May 1, 2014, which is the date it was filed electronically using the Commission's E-Filing System.
