This will acknowledge receipt of your letter dated *February 11, 2014*, which requests that the certificate of public convenience for Group & Party 15 or Less authority at A-6410279, issued to Natan Transportation, Inc., be voluntarily suspended.


After review of the record, it has been determined that a *grant* of voluntary suspension for a period of one year is appropriate. A voluntary suspension is granted once during any consecutive five-year period from the date that your insurance expired, or the date of the request, whichever is earlier. Your request for a voluntary suspension is granted for a period of one (1) year effective *January 31, 2014*, and will terminate on *January 31, 2015*. *No service shall be rendered during the suspension period.*

Prior to resuming operations, at any time during the voluntary suspension, the Commission must be notified in writing of your intention to resume operations. Acceptable evidence of insurance must also be submitted to the Commission prior to resuming operations. Mail the notification and insurance to the **Secretary, PA Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265**. Please be advised that this *grant* of a voluntary suspension does not eliminate the need to pay any fines or fees due the Commission.

If you do not notify the Commission of your intention to resume operations, discontinue your authority, or a transfer application has not been filed on or before *January 31, 2015*, a complaint for abandonment of service will be instituted against you.

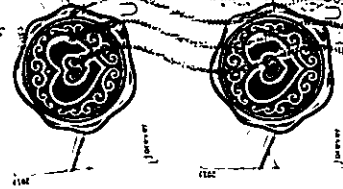
