To expand existing coverage area of Cindy's Carriages, LLC., currently serving the townships of North Fayette, Oakdale, Robinson, Coraopolis, Moon, Findlay and Kennedy, all in Allegheny County, to provide call and demand service to include the area centering on the intersection of 10th Street and East Carson Street, Pittsburgh, PA, 15203 (Pittsburgh's South Side) and a 20 mile radius from that point.

This area has a high demand for service not currently met in full by existing providers. Cindy's Carriages has provided excellent customer service and has been in good standing with the Pennsylvania Public Utilities Commission since its founding in 2010.

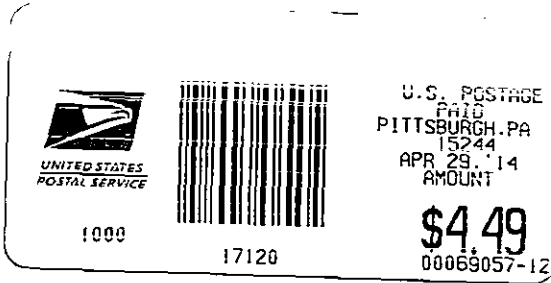
