Dear Ms. Chiavetta:

I would like to contest the above complaint and docket number. Although the 20 day date of the service stated in your letter is past. We didn't physically receive the complaint until this week.

The primary reason for contesting the above is that we never received any correspondence from the PUC regarding applying for an extension for our 2005 Lincoln Town Car, PA Tag# LM28210/Vin# 1LNHM82W5Y611343. In the past the PUC has sent information regarding applying for an extension in July to give operators the necessary time to apply. The only correspondence we received was a letter notifying us of a public hearing that was held on April 4, 2013. Among the items proposed by the commission was item 3, "replace the vehicle age requirement limitation for limousines with a vehicle milage requirement." No additional forms or paperwork related to applying for an extension beyond the eight year limit was ever received by us.


When our records were inspected by Officer Gerald King#17 on January 24, 2014, we told Officer King that we had not received a vehicle extension request form from the PUC and showed him the 4/1/13 letter.
