
Applying increases in hourly rates.

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following rates shall apply for all shipments between points in the Township of Mount Joy, Lancaster County, and within a radius of 75 air miles of said township, to points in PA and vice versa, and, within said request; and originating from points in the borough of Elizabethtown, Lancaster County and fifteen (15) air miles from said borough to points in PA subject to conditions shown in carrier's operating authority, and for shipments, originating in Lancaster County as presently authorized in its existing operating rights, transported distances of forty (40) miles and less.

◆ **TRANSPORTATION RATE TABLE E - CLASS 1 SHIPMENTS (Item 5)**

- NOTE 3 - Rates named in Column 4 apply from 6:01 PM to 12:00 Midnight on any day when a higher rate is shown for the following day.
- NOTE AA - Applicable only on shipments when the distance from original point of origin to final destination is more than 20 miles but not exceeding 40 miles - apply one and one-half hours at the applicable hourly rates.
- NOTE BB - Applicable only on shipments when the distance from original point of origin to final destination is 20 miles or less - apply one hour at the applicable hourly rates.
