By Order entered January, 10, 2013, the Pennsylvania Public Utility Commission approved the Application of C Group Energy Services, LLC to offer, furnish or supply electric generation supplier services as a broker/marketer to residential, small commercial (25 kw and under demand) , large commercial (over 25 kw demand) , industrial and governmental customers in the electric distribution company service territories of PECO Energy Company, Metropolitan Edison Company and PPL Electric Utilities.

By Order entered June 13, 2013, the Pennsylvania Public Utility Commission approved an Amendment to the Application of C Group Energy Services, LLC to offer, furnish or supply electric generation supplier services as a broker/marketer to residential, small commercial (25 kw and under demand) , large commercial (over 25 kw demand) , industrial and governmental customers in the electric distribution company service territories of UGI Utilities, Inc., PECO Energy Company, Metropolitan Edison Company and PPL Electric Utilities.

C Group Energy Services, LLC is requesting an amendment to its license to offer, furnish or supply electric generation supplier services as a broker/marketer to residential, small commercial (25 kw and under demand), large commercial (over 25 kw demand), industrial and governmental customers in the electric distribution company service territories of Duquesne Light Company, West Penn Power, Pennelec and Penn Power. These electric distribution company service territories will be in addition to the already approved service territories of UGI Utilities, Inc., PECO Energy Company, Metropolitan Edison Company and PPL Electric Utilities.

As required to be licensed in the service territories of Duquesne Light Company, West Penn Power, Pennelec and Penn Power, C Group published notice of application in the Johnstown Tribune Democrat, Erie Times-News, Pittsburgh Post-Gazette, Scranton Times, Williamsport Sun Gazette and Harrisburg Patriot-News.
