1. That the Complaint is sustained.
2. That Respondent, within twenty (20) days after service of the final Commission Order, shall forward a penalty of Two Hundred Fifty Dollars (\$250.00), by certified check or money order payable to: Pennsylvania Public Utility Commission, P.O. Box 3265, Harrisburg, Pennsylvania 17120 as provided for in Sections 3301 and 3315 of the Public Utility Code, 66 Pa. C.S. §§3301 and 3315.
3. That Respondent cease and desist from further violations of the Public Utility Code, 66 Pa. C.S. §101 et seq., or any of the rules or regulations of the Commission.
4. That the Department of Transportation not be directed to suspend the vehicle registration(s) of the vehicle(s) listed in paragraph 3 of the Complaint unless, within two (2) years from the date of issuance of the final Commission Order, Respondent again is found to have transported persons or property for compensation between two points in Pennsylvania in violation of the Public Utility Code, 66 Pa. C.S. §101 et seq.


ORDER

3. That Respondent shall pay a fine of six thousand dollars (\$6,000.00), by certified check or money order, within twenty (20) days after service of the Commission order, to:




