



**PREHEARING MEMORANDUM
OF NEXTERA ENERGY POWER MARKETING, LLC**

Pursuant to 52 Pa. Code §§ 5.72-5.75, the public notices published in the Pennsylvania Bulletin on March 22, 2014 and the Prehearing Order dated April 3, 2014, NextEra Energy Power Marketing, LLC ("NextEra") submits this Prehearing Memorandum.

I. PROPOSED PLAN AND SCHEDULE OF DISCOVERY

NextEra is amenable to working with the other parties in this matter to adopt a reasonable proposed plan and schedule of discovery.

II. POSSIBILITY OF SETTLEMENT

NextEra is willing to participate in settlement discussions with any party to narrow the issues in this matter.

III. PRESENTLY IDENTIFIED ISSUES

NextEra has identified the following issues that should be examined in this proceeding:

- Whether changes are required to the Supplier Master Agreement ("SMA") including but not limited to, changes in the Credit terms.

At this time, NextEra continues to evaluate its position on and will refine its position based on further study of the proposals, review of discovery and additional input from other parties. NextEra reserves the right to address other issues identified through its continued review and analysis of the filing or raised by other parties.

IV. AMOUNT OF HEARING TIME NEEDED

At this time, NextEra continues to evaluate the issues in this proceeding and is currently unable to estimate the amount of hearing time that may be needed. However, NextEra believes any hearing time will be minimal, if at all.

NextEra will cooperate with the other parties and the ALJ to facilitate a workable litigation schedule.


