MOTION TO AMEND CAPTION

Direct Energy Services, LLC and Direct Energy Business, LLC submit this Motion to Amend Caption of this proceeding for the following reasons:

1. The Complaint filed in this proceeding makes mentions “Direct Energy” and attaches a copy of a letter from Direct Energy Services, LLC, to the Jeru B. King (“Complainant”).
2. The Complaint was incorrectly captioned against Direct Energy Business, LLC.:
 - a. The Complainant is an individual and bills attached to the Complaint show that the Complainant is a residential electric (Rate RS) customer of PPL Electric Utilities (“PPL”).
 - b. Mr. King was a customer of Direct Energy Services, LLC for retail electric service. Mr. King was not a customer of Direct Energy Business, LLC.
 - c. Direct Energy Services, LLC, is licensed by the Pennsylvania Public Utility Commission (Docket No. A-110164) to provide electric generation supply services to the public in the Commonwealth, including the service territory of PPL.

d. Direct Energy Business, LLC, is licensed by the Pennsylvania Public Utility Commission (Docket No. A-110025) to provide electric generation supply services to the commercial, industrial and governmental customers in the Commonwealth, including the service territory of PPL.

3. Accordingly, Direct Energy Services, LLC, and Direct Energy Business, LLC respectfully request that the caption of this proceeding be amended to read as follows:


