This application is for the discontinuance of Certificate of Public Convenience of the Trolley Company LLC's service to transport, as a motor carrier, persons in group and party service, operating vehicles with a seating capacity of more than 15 passengers, including the driver, between points in Pennsylvania, excluding service that is under the jurisdiction of the Philadelphia Parking Authority, now authorized.





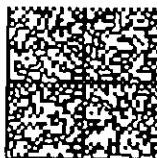
