This means that the decision of the Administrative Law Judge is final without further Commission action.

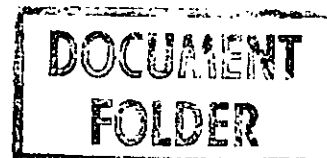
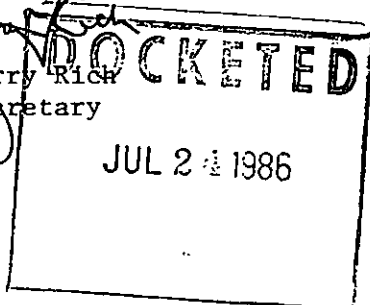

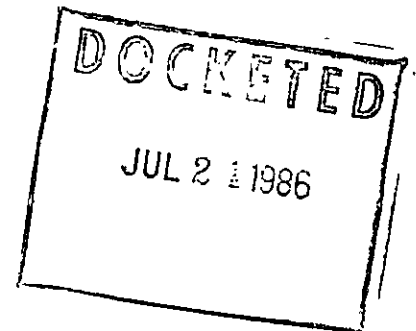
IT IS ORDERED:

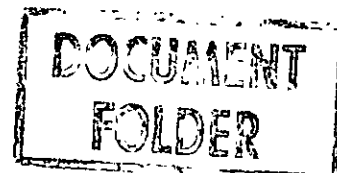
