During the month of March, 1998, Enforcement Officer Don Russell conducted a household goods review of your business operations for the months of May, 1997 through February, 1998.

The following four (4) mores reflect violations of 66 Pa. C.S. §1303, by charging a lesser rate than that specified in your household goods tariff on file with this Commission:

- (a) In the household goods move made for Steve Nielsen, on May 31, 1997, you charged \$462.00, as opposed to the correct charge of \$649.28, resulting in an approximate undercharge of \$187.28.
- (b) In the household goods move made for Ingrid Peterson, on June 12, 1997, you charged \$1,099.30, as opposed to the proper charge of \$1,126.13 resulting in an approximate undercharge of \$26.83.
- (c) In the household goods move made for Paul Wenzler, on July 15, 1997, you charged \$2,111.00, as opposed to the correct charge of \$2,112.00, resulting in an approximate undercharge of \$1.00.






