

PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:

(a) Complainant, Raymond Hall, and Respondent, PPL Electric, agree that the balance of \$2,235.18 was removed from Penn Credit Agency which came from Complainant's previous account for his address at 2730 PENBROOK AVE HARRISBURG PA 17103. Complainant and Respondent further agree that Respondent transferred this balance to Complainant's new account at address 605 WILLOW ST APT I HIGHSPIRE PA 17034, Account #83040-66339. Complainant and Respondent further agree that Complainant will pay

his current monthly bill plus \$38.00 per month toward arrearages, until all arrearages are paid in full. Complainant and Respondent agree that this payment agreement is a one-time offer by Respondent.

(b) Complainant agrees to withdraw his Complaint.


