
Item 10 reflects the new household goods in use operating authority (A-2013-2387553) which was a transfer from Morgan Moving & Storage, Ltd at A-00104711.

SECTION 1
RULES AND REGULATIONS

ITEM 10 - SCOPE OF CARRIER'S OPERATING AUTHORITY

Rates and provisions named in this tariff, or as amended, are limited to their application on Pennsylvania intrastate traffic to the extent of the operating rights set forth below. Unless specifically provided, the provisions are to be interpreted in the same manner as the Pennsylvania Public Utility Commission interprets the Certificate from which the following is quoted.

Certificate No. A-00109787

To transport, as a common carrier, household goods in use, from points in the city of Reading, Berks County, and within five miles of the usually traveled highways of the limits of said city, to points within an airline distance of one hundred statute miles of the limits of said city, and vice versa.

(C) Certificate No. A-00109787
A-2013-2387553.

To transport, by motor vehicle, household goods in use from points in the counties of Montgomery, Chester, Delaware, Bucks, and Berks, to points in Pennsylvania, and vice versa.


