

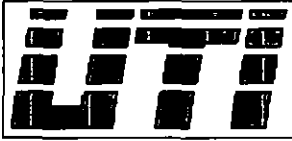

This letter is in response to a May 1, 2014 letter that was sent to Somerset Gas Gathering of Pennsylvania, LLC. The Pennsylvania Public Utility Commission has requested a response to the three (3) questions that were found to be incomplete when the registration renewal was submitted on April 1, 2014. Below are the responses to those questions:

1. Reference application, Docket Number-Applicant has entered an incorrect docket number on their registration form. The applicant's docket number is A-2012-2294264. Please provide an original document by using the submission method listed above.

Response: The filer of the registration form confused the docket number with the utility number. This error has been corrected with the re-filing of the renewal form.


