

NOTE AA - For shipments originating and destined to points within counties named above, the following travel charges will apply when distance from:

- (1) Origin and destination within 10 air miles of carrier's terminal - 1/2 hour at the applicable rates.
- (2) Origin or destination is between 11 and 20 air miles of carrier's terminal - 1 hour at the applicable rates.
- (3) Origin or destination is between 21 and 30 air miles of carrier's terminal - 1-1/2 hrs at the applicable rates.
- (4) Origin or destination is between 31 and 40 air miles of carrier's terminal - 2 hours at the applicable rates.
