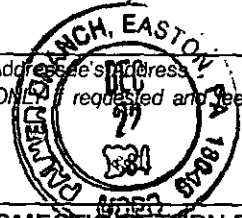

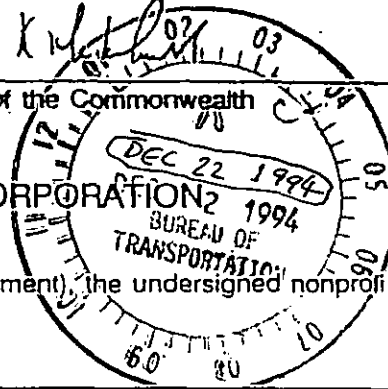

We are enclosing copy of Articles of Amendment filed with the State Department, November 22, 1993.

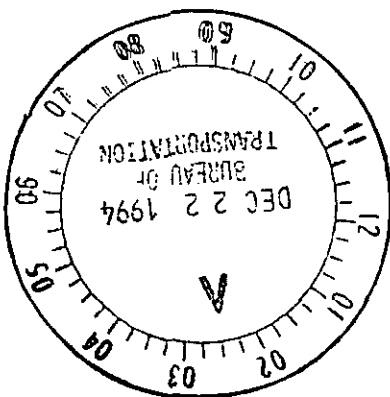
