

Dear Mr. Farinas:

Your letter of May 07, 2014 regarding settlement of all issues as stated in the subject Docket no DOES NOT reflect my satisfaction with the resolution as stated in your letter.

Please be advised that my settlement conference with Ms. Wendy Vacca of PGW included the following agreements:

1. I will be responsible for payment of ACTUAL gas consumption at 7517 Brookhaven Road during the disputed time frame. Actual bills for gas consumption will be submitted by PGW for my review.
2. PGW will perform paving actions needed to return the excavation site to the original condition Prior to forwarding my payments to PGW. I am willing to pay what I owe in care of PUC to be released after the paving repairs are properly performed.

I stressed the fact to Ms. Vacca that I DO NOT want this case to be closed with PUC until all matters are resolved.

The Enclosure to your letter; " Customer statement of account of all charges and transactions for the PGW account for the service address" is entirely exaggerated, contains erroneous charges unknown to me, and shows bills owed where I have cancelled checks proving payment of them in the past. I have tried to contact Ms. Vacca, PGW Supervisor, however, as it is the tradition of PGW employees, I have not received any response from her.

I hereby am informing you that I am not satisfied with the resolution as proposed in the subject letter and fully wish to pursue the above captioned matter against PGW.

My dissatisfactions are forwarded to PUC as recipients of this email and I will follow up with forwarding copies of this email through US mail to your office and PUC officials.

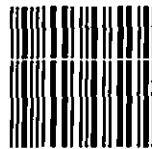
