

(a) Complainant, Nina Williams, and Respondent, PPL Electric, agree that Complainant will make a payment of \$200.00 to Respondent by July 8, 2014. Complainant and Respondent further agree that Complainant will subsequently pay her regular monthly bill plus \$39.36 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's August 2014 due date. Complainant and Respondent further agree that Complainant will be removed from Respondent's budget billing program. Complainant and


Respondent further agree that Respondent will place a referral for Complainant to be re-certified with the OnTrack customer assistance program on August 1, 2014.
