MOTION FOR CONTINUANCE OF HEARING



1. On March 5, 2014, the Commission served the Respondent with the Complaint filed in the above captioned matter, which is a billing dispute.
2. On March 25, 2014, PGW filed an Answer to the Complaint in the above captioned matter.
3. By Notice dated May 7, 2014, the Commission scheduled an In Person Hearing in this matter for Thursday, June 26, 2014 at 10:00 a.m., before Administrative Law Judge Angela T. Jones, in the Commission's Philadelphia office.
