
Dear Secretary Chiavetta:

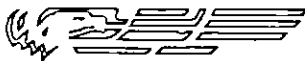
