Dear Pennsylvania Public Utilities Commission,

I am writing to follow up on a Formal Complaint that this office helped Mr. Morton file. Mr. Morton is disputing charges from PECO that he believes were issued in error. When I spoke with Mr. Morton on May 29, 2014, he informed me that he made a payment to PECO as part of a payment arrangement for the outstanding balance he is disputing. Please be advised that Mr. Morton's participation in this payment arrangement **does not** imply that Mr. Morton no longer wishes to dispute the charges on his account. Mr. Morton made the first payment of the payment arrangement solely because that was his only option for having PECO service reinstated at his residence.

Also on May 29, I contacted PECO's finance department about the implications of the payment arrangement for Mr. Morton's Formal Complaint. Both the customer service representative I initially reached and his supervisor assured me that the payment arrangement should have no bearing on the Formal Complaint. PECO continues to consider the account "in dispute," pending a full evaluation by the PUC.


