PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:

(a) Complainant, Antonio C. Fernando, and Respondent, PPL Electric, agree that Complainant will make a payment of \$318.00 to Respondent, PPL Electric, no later than July 16, 2014. Complainant and Respondent further agree that Complainant will be enrolled in Respondent's budget billing program, beginning with Complainant's next bill, and that his monthly budget bill amount for August 2014, September 2014, and October 2014 will be \$175.00. Complainant and Respondent further agree that Complainant will subsequently pay his

regular monthly budget bill plus \$43.00 per month toward arrearages, until all arrearages are paid in full.

(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.
