Notice of Delinquent 2014 Unified Carrier Registration

Your company is receiving this letter because you have a DOT number and your vehicle(s) travel from one state into another, which is classified as an interstate company, or your company is a broker involved in interstate business. Companies involved in interstate business are required to register and pay a fee required by the Unified Carrier Registration (UCR) law. **Our records indicate your company has not yet paid the 2014 fee.** Any company conducting interstate business in 2014 is responsible to pay the 2014 fee.

Companies that pay the UCR fee

Any company which "provides transportation of property or passengers in order to support their business" is a motor carrier. If your company is transporting or delivering their own products (for example carrying tools or equipment to provide services, or your own merchandise or products), or for any other reason operating the vehicles out of state in the course of the business, the company is considered a motor carrier or motor private carrier and must register and pay the UCR fee.

Fees will fund motor carrier safety and enforcement programs in Pennsylvania. Since you have not registered and paid your UCR fee, the PUC encourages you to pay your fee as soon as possible to avoid having to pay a fine while travelling in another state.

Changes in Company Information

If you have gone out of business, do not travel into other states, are leased to another company, have a new address, or have a change in the number of vehicles, you need to update your company information. This is done by filing a Motor Carrier Identification Report (MCS-150) with the FMCSA. You may update your information on-line by creating a "FMCSA Portal Account" at <http://portal.fmcsa.dot.gov> . You can also use the enclosed MCS-150 and return to: UCR Program, Pa PUC, PO Box 3265, Harrisburg, PA, 17105-3265.

How to Register and Pay the Fee - You Have Two Options

1. *On-line.* To avoid delays, we strongly recommend that you register on-line. Go to www.ucr.in.gov and follow the instructions. The instructions on the UCR web site will guide you through the registration process. Payments may be made on-line using MasterCard, Visa or e-check, and you may print a receipt from the web site. There is a fee for credit card and a \$4.00 fee for e-check payments. There is no fee for checks that are sent in with a form. Please make sure you are at a website address ending in "gov." Any other website which ends in ".com" will result in large fees being included.

2. *Mail.* To register by mail, please complete the enclosed UCR application form and send your application and payment to: **UCR Program, PA Public Utility Commission, PO Box 3265, Harrisburg, PA 17105-3265.** Checks or Money Orders must be made payable to the **"Commonwealth of Pennsylvania."** **Please do not send cash.** You will not receive a receipt for payments made by mail.

If you have recently paid this fee, please disregard this letter. You may check for proof of payment at www.ucr.in.gov, and click on the "view UCR information" link.

The fee was due by December 31, 2013, so to avoid any fines while your vehicle is out of the state, it is advisable to pay as soon as possible. New carriers or brokers should pay as soon as possible as there is no grace period for newly acquired numbers.

If you receive an e-mail requesting you pay the fee through a company, please read carefully before proceeding. The computer-generated e-mail from the PUC will come from ucrlink.com and direct you to the UCR website (www.ucr.in.gov). Payment to any site other than the UCR site ending in [.gov](http://gov) may result in additional fees being added to the payment. Be aware that no one from the PUC, the DOT, or the FMCSA will contact you asking for your banking information.

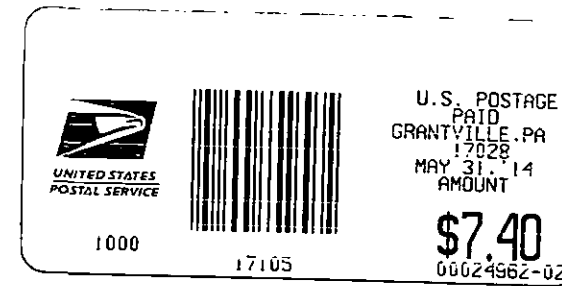
