Dear Mr. McNulty:

CTC Communications Corp. (the "Company"), an authorized telecommunications carrier in Pennsylvania<sup>1</sup>, hereby respectfully notifies the Pennsylvania Public Utilities Commission ("Commission") that it has adopted a fictitious name for use in Pennsylvania. The Company has adopted the d/b/a "One Communications."

As the Commission is aware, CTC Communications Group, Inc. has merged with and into One Communications Corp. (f/k/a Choice One Communications Inc.), with One Communications Corp., the ultimate parent of the Company, surviving the merger. This change in control did not involve the transfer of operating authorities, assets or customers – the Company will continue to offer the same services at the same rates, terms and conditions. However, in order to integrate the operations of the Company and its affiliates, and to avoid customer confusion, the Company and its affiliates have each adopted a d/b/a using the "One Communications" name. The adoption of this d/b/a by the Company and its affiliates will also enhance their ability to market their services, thereby benefiting consumers in Pennsylvania.

Please note that nothing substantive has changed in the tariff; the only change is the addition of the Company's fictitious name. Regarding customer notice, customers of the Company will receive written notice of the fictitious name through a bill notification. Both the Company name and the fictitious name will appear on the billing statements for a period of two months. To the extent that any customers have questions about the fictitious name appearing on their bills, the Company will respond to such inquiries individually.




