**ANSWER**

Good Cab, LLC, through its attorney, Justine L. Pate, Esq. hereby answers the above stated Complaint as follows:

1. The averments regarding Commission authority and of the company name and address of Good Cab are admitted.
2. The averments stating the time and date of the inspection noted in the Complaint are admitted.
3. Denied in part. Regarding the averments related to a *Criminal History Record*, Respondent possessed Criminal History Records from Dauphin County, and was unaware of the problem until the inspection. Moreover, said problems were corrected as soon as possible subsequent.
4. Denied in part. Regarding the fast meter violation and air conditioning, Good Cab was unaware of the problem until the inspection by the Commission agent; said problems were corrected as soon as possible subsequent. Good Cab affirms the alleged violation for four matching wheel covers.
5. Good Cab, because of the mitigating circumstances stated above, and for it's effort in correcting the aforesaid allegations above prays for lenience regarding the three alleged violations.



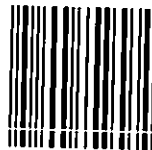
