

PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainant, Arthur Johnson, and Respondent, PPL Electric, agree that Complainant will pay his regular monthly bill plus \$28.00 per month toward arrearages, until all arrearages are paid in full. Complainant and Respondent further agree that Complainant's first payment is due no later than July 28, 2014. Complainant and Respondent further agree that Respondent performed a test of Complainant's electric meter, and that Complainant's meter tested as 99.732% accurate.

(b) Complainant agrees to withdraw his Complaint.
