The Act further provides that the Small Business Advocate is to issue publicly a written statement stating concisely the specific interest of small business consumers to be protected by his initiation of or intervention in any proceeding involving those interests before the Public Utility Commission ("Commission") or any other agency or court. This public statement relates to the filing today by the Small Business Advocate of an Intervention in the above-captioned Commission proceeding.

On June 20, 2014, the Office of Consumer Advocate filed a Joint Complaint with the Office of Attorney General through the Bureau of Consumer Protection against IDT Energy, Inc.
