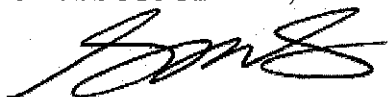
CERTIFICATE OF SATISFACTION

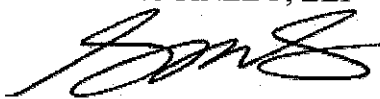
