As you know, Provident Energy Consulting, LLC recently filed a license application with the Pennsylvania Public Utility Commission as a Natural Gas Supplier. This application was originally filed on January 29, 2007 under Docket Number A-125151.

After reviewing our Application, Commission staff from the Bureau of Fixed Utility Services informed us that service areas of intended service as announced in the License Application (Item #10, Page #5) are not approved on a geographic basis, rather on a utility service territory basis. In effect, though Provident Energy had not planned to pursue clients in the far western part of Pennsylvania, we were informed that we must, nonetheless, advertise our intention to seek a license application in the Pittsburgh and Erie regions, since a few of the gas distribution companies serving Eastern Pennsylvania have service territories that also include areas in the western part of the Commonwealth.

Since we must now include notifications and advertisements in the two remaining newspapers necessary for a statewide presence, we would like to amend our application to include statewide authority instead of simply the specific areas initially stated.

We are serving everyone a copy of our Amendment request by copy of this letter, as well as two attachments:

- Attachment 1: a new Item #10 on Page #5 of the original application, which revises our intended Service Area as "All of Pennsylvania", and
- Attachment 2: a new Item #13 on Page #6 of the original application, which lists all parties who will receive this letter and its enclosures; though with the additional enclosure of our original application in its entirety to those natural gas distribution companies who had not been sent a copy of our original filing.



Please note that we have scheduled notice of our application to be published in the following newspapers' Legal Notices Departments on or about February 20, 2007.

As you know, Provident Energy Consulting, LLC recently filed a license application with the Pennsylvania Public Utility Commission as a Natural Gas Supplier. This application was originally filed on January 29, 2007 under Docket Number A-125151.

After reviewing our Application, Commission staff from the Bureau of Fixed Utility Services informed us that additional information was needed to make the application complete. The requested information was to include the following:

- 1. Affidavit attesting to publication in the Erie Daily Times and the Pittsburgh Post-Gazette and Proofs of Publication.
 - Notice of our Application was published in both the Erie Daily Times and the Pittsburgh Post-Gazette on February 20, 2007. A copy of the Proof of Publication for the Erie Daily Times is enclosed. We were informed by the Pittsburgh Post-Gazette that the Proof of Publication would be forthcoming approximately 10-14 days after publication. Therefore, I am enclosing a copy of the ad from the online edition of the Post-Gazette and will forward the Proof of Publication as soon as we receive it.

- 3. Provide current information to demonstrate financial fitness.
 - I have enclosed a letter from our bank, Citizens Bank of Pennsylvania, attesting to the good standing of our accounts at their institution. Also enclosed is a packet from CNA Insurance, which provides detail of our Professional Liability, Workers Compensation and Property coverage's. This information was deemed to be acceptable by Mr. James Shurskis of Fixed Utility Services who we contacted for clarification of needed items.
- 4. Proof of compliance with the bonding requirement at 66 Pa.C.S. §2208 (c) of Natural Gas Choice and Competition Act.
 - We have contacted or attempted to contact each of the Natural Gas Companies with T&D facilities in Pennsylvania, using the list in Item #13, "Natural Gas Supplier License Application, PA PUC Document # 139346". We learned that some companies listed in that document are no longer in business under the name therein; e.g., "Peoples" and "Carnegie" now operate under "Dominion" and "Equitable". Also, some of the contact names are dated. Whenever we learned of such needed corrections, we informed Mr. Shurskis of suggested revisions. After speaking to or dialoguing through email with the appropriate individual(s) at each gas distribution company, there was a consistent answer from each and every responding company, essentially that Provident Energy would not be required to provide any form of security/collateral unless and until we were interested in becoming an active supplier on their system. While we are still awaiting responses from some of the companies, I have enclosed copies of correspondence from those responding companies for your review. A listing of the companies in the PUC Licensing Application and an update on their response status is included in the enclosure.

I hope this letter provides the information needed to complete a review of our application. If I can be of further assistance, please contact me at your convenience and I will be certain to respond in a timely manner.

 - We have contacted or attempted to contact each of the Natural Gas Companies with T&D facilities in Pennsylvania, using the list in Item #13, "Natural Gas Supplier License Application, PA PUC Document # 139346". We learned that some companies listed in that document are no longer in business under the name therein; e.g., "Peoples" and "Carnegie" now operate under "Dominion" and "Equitable". Also, some of the contact names are dated. Whenever we learned of such needed corrections, we informed Mr. Shurskis of suggested revisions. After speaking to or dialoguing through email with the appropriate individual(s) at each gas distribution company, there was a consistent answer from each and every responding company, essentially that Provident Energy would not be required to provide any form of security/collateral unless and until we were interested in becoming an active supplier on their system. While we are still awaiting responses from some of the companies, I have enclosed copies of correspondence from those responding companies for your review. A listing of the companies in the PUC Licensing Application and an update on their response status is included in the enclosure.

As previously discussed, PPL Gas Utilities Corp. has no issues regarding the assignment of a retail gas marketing license to Provident Energy from the Commonwealth. Although unnecessary from our perspective, if Provident Energy feels it will expedite data requests from other utilities or improve the level of service they can offer their customers, PPL Gas has no objections.

In the future, if Provident Energy desired to enter the retail natural gas supply market on the PPL Gas Utilities system, PPL would require that Provident also meet the criteria set forth within our currently approved tariff. Included in those criteria are the execution of a Daily Aggregation and Balancing Agreement or a Monthly Aggregation and Balancing Agreement and demonstration of credit qualification to the satisfaction of PPL Credit Risk. Until these requirements are met Provident Energy would not be permitted to conduct the normal business of an approved Natural Gas Supplier (NGS) on the PPL Gas Utilities system.

In consideration of the above;

In the absence of an executed operating agreement between PPL Gas Utilities Corporation and Provident Energy Consulting LLC, PPL will not permit retail operations by this entity. Therefore, PPL does not require security from Provident Energy Consulting LLC, at this time.

As per our conversation, I'm writing to include an email address for Jim Shurskis of the PUC's Fixed Utility Services Group. Please get back to me and copy Jim with any of the bonding or credit requirements PPL Gas might require of Provident Energy as we act to serve our customers with energy information and purchasing assistance. As I've explained, Provident Energy serves strictly as a consultant to our clients, advising them on energy efficiency or purchasing strategies to reduce their costs. We have operated as a licensed EGS in PA since 1998, serving as a broker/marketer to aid clients in advantageous, cost-effective purchasing. We have never had a single blemish on our record. Though the gas licensing legislation is more liberal in its requirements than the electric legislation, and recognizing that we don't need a gas license to do what we do, we are simply pursuing this license as a means to more timely receipt of historical usage data. While we work with many gas utilities to obtain such data through an "Authorization to Release ..." form, our experience has been that some utilities are short-staffed and take a bit longer than others to get us the usage information we need in a reasonable time period. In such cases, a license will permit us to work with an inhouse "supplier group" that generally turns things around in a day or two.

In a nutshell, we do not serve retail customers with a single electron of molecule and simply are pursuing this license for ease of data gathering. If such an activity requires some special security, please advise. This letter will confirm our discussions regarding PECO Energy's creditworthiness review for the gas transportation suppliers.

As we discussed, in accordance with the PECO Gas Service Tariff, Rule 25, a supplier must satisfy at least one of the financial criteria listed below to participate in the transportation program:

(1) The NGS has a minimum credit rating of 3A2 from Dun & Bradstreet, a minimum bond rating of Baa2 from Moodys, or a rating of BBB from Standard & Poor's, Fitch ICBA or Duff & Phelps;

or

(2) The NGS has furnished the Company with an irrevocable and binding form of security (e.g., surety bond, letter of credit, security interest in collateral acceptable to the Company, a corporate guaranty, or a written affirmation of financial support by a parent or affiliated company) issued by an obligor that has a minimum credit rating of 3A2 from Dun & Bradstreet, a minimum bond rating of Baa2 from Moody's, a minimum bond rating of BBB from Standard & Poor's, Fitch ICBA or Duff & Phelps, or, for an insurance company, an A.M. Best credit rating of no less than A-and in which the obligor designates the Company as the sole beneficiary and which otherwise is in a form and amount acceptable to the Company;

or

(3) The NGS provides the Company with a cash deposit and/or a cash escrow arrangement in an amount and form acceptable to the Company.

Because Provident Energy does not meet the minimum rating requirements set forth in #1 above, in order to enroll customers for natural gas supply in the transportation program, it will need to satisfy item #2 or #3 of the financial criteria at the time it elects to enroll customers for natural gas supply in PECO's program.






