The above captioned transfer application has been assigned to me for the preparation of a Commission order in the matter.

In reviewing the authority to be transferred, I note that right number 2 permits transportation for Railway Express Agency, Inc. (REA). To the best of my knowledge, REA is no longer in business. Generally, when a shipper ceases to exist, the Commission will eliminate such a right. It is my intention to recommend the elimination of this right unless the applicant can provide some good reason for retaining the right to serve REA.

Please submit a written statement either agreeing to the elimination of the right or the reasons why it should be retained. I will hold the record open for thirty (30) days, until August 19, 1988, for your response.
