

1. By notice of hearing dated February 21, 2014, a hearing was scheduled in the within matter for April 7, 2014.

2. By notice dated February 26, 2014, the hearing was court-rescheduled for April 28, 2014, a date on which counsel for complainant was not available.

3. By orders dated March 11, 2014 and April 28, 2014 the matter was continued, at complainant's counsel's request, to June 24, 2014.
