CERTIFICATE OF SATISFACTION


1. Complainant is Tammy Scott.

 - (a) Complainant, Tammy Scott, and Respondent, PPL Electric, agree that Complainant's budget bill has been reset to \$200 per month. Beginning with the bill due August 5, 2014, Complainant agrees to pay her monthly budget bill of \$200 plus \$155 per month towards arrearages until all arrearages are paid in full.
