O R D E R

BY THE COMMISSION:

On March 21, 1988, Joseph Sparacino Movers, Inc. (Sparacino) filed an application for a transfer of the rights authorized under the certificate issued at A-92104 to Joseph N. Sparacino, t/d/b/a Joseph N. Sparacino Trucking. The application was docketed at A-108084.

By Letter-Petition received May 12, 1988, Sparacino requests that it be permitted to retain its docket number at A-92104. This proceeding basically involves the incorporation of a family business.

Although this Commission has, on one other occasion, approved a petition to retain a docket number, circumstances were different. In Sparacino's Petition, it alleges that its name and number are very well established with the public in its area and that a new number may affect future business. However, Sparacino is changing its name from Joseph N. Sparacino Trucking to Joseph Sparacino Movers, Inc. Sparacino contends that its current number is shown on freight bills, bills of lading, calling cards and vehicles.

The current computer system used by this Commission is such that each new application filed with us must receive and maintain its own docket number. Otherwise, in this case, it would be impossible to differentiate between the individual and the corporation. For this reason, the Petition should be denied.

However, because Sparacino is merely incorporating a family business, we will give it six months to transform its freight bills, bills of lading, calling cards and vehicles to the new docket number. All correspondence filed with the Commission (i.e., Annual Reports, Assessments, Insurance) must contain the new docket number from the date of approval of the transfer application; THEREFORE,


IT IS ORDERED:

1. That the Letter-Petition at A-108084 to retain a docket number filed by Joseph Sparacino Movers, Inc. on May 12, 1988 is hereby denied.

2.. That Sparacino is hereby given six months from the date of service of an order approving the transfer application, if approved, to transform its freight bills, bills of lading, calling cards and vehicles from the previous docket number at A-92104 to the new docket number at A-108084.

3. That all correspondence filed with this Commission must contain the new docket number from the date of service of this order.
