Kathleen Harris v. IDT Energy, Inc., PA PUC Docket No. C-2013-2347594

Formal complaint filed at the PA PUC against IDT Energy, Inc. by a customer who claimed that her electric bills were too high. IDT filed an answer to the complaint explaining that the large past-due balance appearing on the customer's account was actually accrued by the customer when she was with the utility, prior to her enrollment with IDT and thus had nothing to do with IDT's supply service. The case was settled between the parties and a Certificate of Satisfaction was filed on June 10, 2013.

Warren Bray v. IDT Energy, Inc., PA PUC Docket No. F-2013-2373176

Formal complaint filed at the PA PUC against IDT Energy, Inc by customer regarding alleged incorrect charges for electric service. The case was settled and a certificate of satisfaction was filed on July 23, 2013.

The remainder of the customer formal complaints listed on <u>Exhibit 6</u> are related to pricing issues caused by the Polar Vortex of 2014. As reflected on Exhibit 6, IDT Energy has satisfied nearly all of the formal complaints, with the exception of three complaints that are currently in mediation

Pennsylvania PUC Bureau of Investigation and Enforcement v. IDT Energy, Inc., PA PUC Docket No. M-2013-2314312

This matter involved an informal investigation by the PAPUC's Bureau of Investigation and Enforcement (I&E) into informal customer complaints to the PAPUC's Bureau of Consumer Services regarding marketing contacts initiated by IDT's independent, third-party sales agents.

IDT fully cooperated with I&E throughout the course of the investigation, and the parties reached a settlement of the investigation without any findings of a violation by IDT. The Settlement was approved by the Commission by Order entered on October 17, 2013. The Settlement required IDT to pay a civil penalty of \$39,000 and to comply with additional reporting requirements and compliance actions as detailed in the Agreement.



Summary of Technical Fitness

Residents Energy, LLC ("Residents Energy") is a wholly owned subsidiary of IDT Energy, Inc. ("IDT Energy") and will leverage the experience and resources of IDT Energy as it develops its brand. As an affiliate of IDT Energy, Residents Energy will utilize many of the same employees and third party vendors as IDT Energy. IDT Energy has been licensed as an NGS in Pennsylvania since 2009, an EGS in Pennsylvania since 2010, and is also licensed as a competitive gas and/or electricity supplier in New Jersey, New York, Maryland, Illinois and the District of Columbia. IDT Energy currently serves nearly 430,000 natural gas and electric meters in the states in which it is licensed.

Whereas IDT Energy primarily offers a pure variable rate product to customers on a month-tomonth basis, Residents initially intends to focus on offering residential and small commercial customers fixed rate contracts.

Residents Energy is dedicated to providing the very best in customer service and price and will strive to continually improve its ability to compete in the energy supply marketplace. To this end, Residents Energy has and will continue to develop a comprehensive process to identify and provide highly competitive products and services to its customer base, while maintaining profitability.

Residents Energy will leverage the IDT Energy in-house customer service staff to handle incoming customer calls. Additional staffing will be added as needed to accommodate growth. Residents Energy will utilize the ongoing training and support systems that IDTE has in place for handling incoming calls concerning bill inquiries, overpayment, complaints, and sign-ups. Residents Energy will also utilize IDT Energy's system of placing outbound calls for quality control.

Customer service will be handled mainly through a call center located in Jamestown, NY. The call center employs 42 inbound and outbound customer service representatives and supervisors and is staffed from 8:00 am to 7:00 pm, Monday through Friday with both English and Spanish-speaking representatives.

Sales and marketing regulatory compliance is of paramount importance to IDT Energy and will be to Residents Energy as well. Residents Energy will employ IDT Energy's existing marketing regulatory compliance safeguards, which include:

- employing 14 Sales and Marketing Quality Control Agents who monitor third party verifications, research complaints and conduct outbound calls to qualitycheck a significant sample of the sales made by independent agents each day
- monitoring third party verifications interviewing customers during call-backs to confirm the customer's understanding of the offer.
- requiring independent sales contractors to utilize company-approved scripts for all sales contacts.
- requiring independent sales contractors to perform national background checks on all door-to-door sales agents.

- requiring all independent sales contractors to complete a rigorous training program prior to representing the company
- requiring all independent sales contractors to establish and maintain an internal
 quality control process by which all sales agents are monitored for compliance to
 company scripting and policies.
- requiring all independent sales contractors to maintain and enforce an internal Do Not Call and Do Not Knock list and to confirm regular scrubbing of the National and Pennsylvania Do Not Call Registries.
- utilizing a data processing team that tracks customer enrollments and cancellations to make sure they are done in accordance within the required timelines.
- utilizing third-party verification contractors to verify every enrollment that results from a sales call.
- auditing of the activities of third party sales agents by a Vice-President for Customer Service and Regulatory Affairs who has worked in the electric and natural gas supplier industry for 16 years, along with two other dedicated managers.

Residents Energy will also utilize the expertise of IDT Energy personnel with respect to regulatory compliance, finance, energy procurement, risk analysis, and portfolio management. As a supplier operating successfully in Pennsylvania since 2009, IDT Energy has demonstrated that it possesses the requisite technical expertise to be an electricity and natural gas supplier, and Residents Energy will be utilizing that same technical expertise in its operations.

TERMS OF SERVICE AND DISCLOSURE STATEMENT

This is an agreement for electric generation services, between Residents Energy, LLC ("Residents", "us" or "we") and

Residents is licensed by the Pennsylvania Public Utility Commission to offer and supply electric generation services in Pennsylvania. Our PUC license number is ______, Your generation prices and charges will be set by Residents. The Public Utility Commission regulates distribution prices and services. The Federal Energy Regulatory Commission regulates transmission prices and services.

You will continue to receive your bill from your Electric Distribution Company (EDC) for all supply and delivery charges, your EDC will continue to provide all emergency repairs and services.

Start Date – This Agreement will begin on the date of the first actual or estimated meter read after your enrollment is accepted by your EDC, in accordance with the switching rules of the EDC and the PUC.

Right of Rescission - You may cancel this Agreement at any time before midnight of the fifth business day after receiving this disclosure.

Definitions - Generation Charge - Charge for production of electricity. Transmission Charge - Charge for moving high voltage electricity from a generation facility to the distribution lines of an electric distribution company.

Basic Service Prices - Residents offers a variable price for all electric generation sold under this Agreement. The price for electric generation sold is established on an approximately monthly basis based upon electric generation market pricing as furnished by PJM clearing house, transportation or transmission, and other market and business price related factors. This price may be higher or lower than the EDC's price in any

particular month. There is no ceiling on the price for electric generation sold under this agreement, and there is no limit or the amount that your price can decrease or increase from month to month. Electric generation supply charges include estimated total

state taxes. Residents will comply with all required laws regarding sales tax and will include or exclude the appropriate sales taxes in each jurisdiction served, if any, as required by the Pennsylvania Department of Revenue for all Electric generation supply charges. Customers can call Residents' Customer Service Dept. at 888-828-7374 for current variable pricing rates and historical prices. <u>Please note that historical prices are not indicative of present or future pricing.</u>

Starting Price- Your initial price for electric generation will be _____. This price will apply to your first month of service from Residents, and thereafter, your rate will vary from month to month as explained above.

Renewable Energy Supply Option - "Renewable" energy refers to energy that is generated from, renewable sources, such as solar, wind, water or biomass. If a customer chooses a renewable supply option, Residents will ensure that 100% of the customer's electricity usage is matched with renewable energy certificates or renewable energy attributes. Residents shall have up to 24 months from the end of each calendar year to address any deficiency that may have arisen in the renewable content of electricity sold under this Agreement during such calendar year. The price for renewable energy will be comprised of the Residents variable price plus an amount that represents Residents' cost in acquiring the renewable energy certificates or renewable energy attributes which shall not exceed three (3) cents per kwh.

Rebates and Introductory Price/Special Promotion Options - From time-to-time Residents may offer rebates or special promotions. If a Customer participates in a rebate program, the Customer must remain in the program for the entire agreed upon term in order to qualify for the rebate. If a Customer cancels at any time prior to the agreed upon term, the Customer shall forfeit all rights and claims to any and all rebate offers. All rebate amounts advertised and presented to customers are estimates based upon customer's prior electric and/or natural gas usages. Actual rebate amounts will be based on customer's actual usage over the term of this agreement, which may very from any estimate. From time-to-time Residents may offer eligible new customers an introductory price which will be in effect for the introductory price term. Upon expiration of the introductory price term the price shall revert to a standard variable price.

Residents will send any rebate or promotion payment to the customer address given to Residents at the time of sign-up. It is the responsibility of the customer to notify Residents of any changes to the customers billing address either in writing to: 20 West Third Street, Suite 10, PO Box 400, Jamestown, NY 14702 or by calling Residents' Customer Service Dept. at 888-828-7374. Residents will send all rebates and promotional payments and notices via first class mail and is not responsible for invalid addresses or undelivered items.

Length of Agreement - You will buy your electric generation services for your use from Residents beginning on a date set by your EDC and continuing on a month-to-month basis until either party provides at least fifteen (15) calendar days' notice of its intent to cancel and until EDC completes the termination in accordance with its rules.

Penalties, Fees and Exceptions - There are no fees or early cancellation penalties for canceling Residents' variable rate plan.

Payment Provisions- All payments are to be made to your EDC. Any unpaid amounts shall be subject to late payment charges. Your EDC may request a security deposit for amounts which include supplier charges. Your EDC maintains the right to terminate service for any unpaid utility or supplier charges, pursuant to Pennsylvania Public Utility Code regulations.

Cancellation Provisions - A residential customer may cancel this Agreement at any time during the three (3) business days following receipt of this Agreement by calling Residents at 888-828-7374. After that time, this Agreement shall continue until either party provides the other with at least fifteen (15) calendar days' notice of its intent to cancel and until the EDC completes the cancellation in accordance with its rules.

Renewal Provision - This Agreement shall continue until either party provides at least fifteen (15) calendar days' notice of its intent to cancel and until EDC completes the cancellation in accordance with its rules.

Agreement Expiration/Change in Terms - If you have a fixed term agreement with us and it is approaching the expiration date or if we propose to change our terms of service, we will send you two advance written notices either in our bills or in separate mailings between 30 and 60 days before either the expiration date or the effective date of the changes. On January 25, 2013, you filed on behalf of New Energy Services LLC (New Energy) an application for market-based rate authority with an accompanying tariff. The proposed market-based rate tariff provides for the sale of energy, capacity, and ancillary services at market-based rates.¹ New Energy requests waivers commonly granted to similar market-based rate applicants.

Your filing was noticed on January 28, 2013, with comments, protests or interventions due on or before February 15, 2013. None was filed.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation - West, under 18 C.F.R. § 375.307, your submittal filed in the referenced docket is accepted for filing, effective March 1, 2013, as requested. Based on your

representations, New Energy meets the criteria for a Category 1 seller in all regions and is so designated.²

You state that New Energy is located in New Jersey, and intends to act as a power marketer. You further represent that New Energy is indirectly owned by Genie Energy Ltd. Further, you affirmatively state that New Energy has not erected barriers to entry and will not erect barriers to entry into the relevant market.

You represent that New Energy meets the criteria for Category 1 seller status in all regions. You represent that New Energy does not own or control, and is not affiliated with any entity that owns or controls, generation or transmission facilities. You state that New Energy is not affiliated with a franchised public utility and that New Energy does not present any other vertical market power concerns.

Market-Based Rate Authorization

The Commission allows power sales at market-based rates if the seller and its affiliates do not have, or have adequately mitigated, horizontal and vertical market power.³

Based on your representations, New Energy's submittal⁴ satisfies the Commission's requirements for market-based rate authority regarding horizontal and vertical market power.

New Energy's request for waiver of Subparts B and C of Part 35 of the Commission's regulations requiring the filing of cost-of-service information, except for sections 35.12(a), 35.13(b), 35.15 and 35.16 is granted. New Energy's request for waiver of Part 41, Part 101, and Part 141 of the Commission's regulations concerning accounting

and reporting requirements is granted with the exception of 18 C.F.R. §§ 141.14 and 141.15.⁵ Notwithstanding the waiver of the accounting and reporting requirements here, New Energy is expected to keep its accounting records in accordance with generally accepted accounting principles.

New Energy requests blanket authorization under Part 34 of the Commission's regulations for all future issuances of securities and assumptions of liability. A separate notice was published in the Federal Register establishing a period during which protests could be filed. None was filed. New Energy is authorized to issue securities and assume obligations or liabilities as guarantor, indorser, surety, or otherwise in respect of any security of another person; provided that such issue or assumption is for some lawful object within the corporate purposes of New Energy, compatible with the public interest, and reasonably necessary or appropriate for such purposes.⁶

New Energy must file electronically with the Commission Electric Quarterly Reports. New Energy further must timely report to the Commission any change in status that would reflect a departure from the characteristics the Commission relied upon in granting market-based rate authority in accordance with Order No. 697. 8
