MOTION FOR DEFAULT JUDGMENT

NOW COMES the Pennsylvania Public Utility Commission’s (“Commission”) Bureau of Investigation and Enforcement (“I&E”), by its prosecuting attorneys, and files this Motion for Default Judgment against Charles S. Novosel (“Respondent”) pursuant to Section 5.103 of the Commission’s regulations, 52 Pa. Code §5.103. In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on March 26, 2014 by filing a Complaint. The Complaint was served by certified mail on March 27, 2014.
2. Attached to the Complaint was a Notice advising Respondent that it must file an Answer within twenty (20) days of service of the Complaint.
3. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.
4. On March 31, 2014, Respondent signed a receipt confirming that it received the Complaint. A true and correct copy of proof of delivery of the Complaint is attached as Exhibit 1.
5. The twenty (20) days to file an Answer to the Complaint expired on April 16, 2014.

6. Respondent did not file an Answer to the Complaint.
7. Pursuant to Section 5.61(c) of the Commission's regulations, a Respondent who fails to file an Answer to a Complaint within the 20-day response period may be deemed in default, and the relevant facts stated in the Complaint may be deemed admitted. 52 Pa. Code §5.61(c).
8. The Commonwealth Court has upheld the Commission's authority to sustain complaints that are not answered within twenty days. *See Fusaro v. Pa. PUC*, 382 A.2d 794, 797 (Pa. Cmwlth. 1978).
9. Respondent did not pay the \$3,000 civil penalty that was requested in the Complaint for Respondent's failure to file 2010, 2011 and 2012 assessment reports.
10. I&E respectfully requests that the Commission enter a Default Order against Respondent that:
 - a. Directs Respondent to pay the \$3,000 civil penalty within thirty (30) days of the entry date of the Commission's Order; and
 - b. Directs the Bureau of Technical Utility Services to cancel Respondent's certificate of public convenience at A-00122515 if the civil penalty is not timely paid.



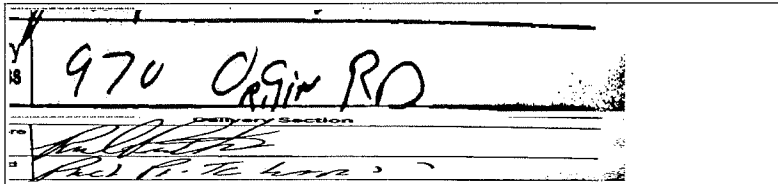
