MOTION FOR DEFAULT JUDGMENT

NOW COMES the Pennsylvania Public Utility Commission’s (“Commission”) Bureau of Investigation and Enforcement (“I&E”), by its prosecuting attorneys, and files this Motion for Default Judgment against Gary A. Ladigan t/a Gary A. Ladigan Trucking (“Respondent”) pursuant to Section 5.103 of the Commission’s regulations, 52 Pa. Code §5.103. In support thereof, I&E respectfully represents as follows:

1. I&E commenced this action on April 1, 2014 by filing a Complaint.

2. On April 4, 2014, the Complaint was served by certified mail to Respondent at 5771 Fritzingler Road Germansville, PA 18053.
3. This was the last known mailing address that Respondent provided to the Commission at the time that the Complaint was served.
4. On April 15, 2014, the Complaint was returned to the Commission by the United States Post Office and was marked as “Return to Sender, Not Deliverable As Addressed, Unable to Forward.”
5. Subsequent to the time that I&E’s Complaint was filed and served, Respondent updated its mailing address with the Commission as follows: 1115 Forest Road Hazleton, PA 18202.
6. On April 21, 2014, the Complaint was re-served to Respondent at its new address.

7. While there is no record that this Complaint was returned to the Commission, I&E was unable to obtain certification that Respondent received the Complaint.
 8. Therefore, pursuant to the Commission's procedural regulations at 52 Pa. Code §1.53(e), the Complaint was published in the Pennsylvania Bulletin on June 14, 2014. *See 44 Pa. Bull.* 3667 (June 14, 2014).
 9. Included with the Complaint was a Notice advising Respondent that it must file an Answer within twenty (20) days.
 10. The Notice also advised Respondent that if it failed to answer the Complaint, I&E would request that the Commission issue an Order imposing the penalty set forth in the Complaint.
 11. Respondent did not file an Answer to the Complaint.
 12. Pursuant to Section 5.61(c) of the Commission's regulations, a Respondent who fails to file an Answer to a Complaint within the 20-day response period may be deemed in default, and the relevant facts stated in the Complaint may be deemed admitted. 52 Pa. Code §5.61(c).
 13. The Commonwealth Court has upheld the Commission's authority to sustain complaints that are not answered within twenty days. *See Fusaro v. Pa. PUC*, 382 A.2d 794, 797 (Pa. Cmwlth. 1978).
 14. Respondent did not pay the \$2,000 civil penalty that was requested in the Complaint for Respondent's failure to file 2011 and 2012 assessment reports.

15. I&E respectfully requests that the Commission enter a Default Order against Respondent that:

- a. Directs Respondent to pay the \$2,000 civil penalty within thirty (30) days of the entry date of the Commission's Order; and
- b. Directs the Bureau of Technical Utility Services to cancel Respondent's certificate of public convenience at A-2008-2014358 if the civil penalty is not timely paid.


