1. The above-captioned application is hereby amended so that the authority sought shall be as followings:

Between points in the City and County of Philadelphia and from points in said City and County to points in Pennsylvania.



3. If the Restrictive Amendment is not accepted by the Commission, the parties agree that further hearings shall be held to permit the parties to present evidence.

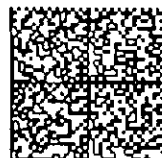
