

Miller, and Respondent, PPL Electric, agree that Complainant will be enrolled in Respondent's budget billing program, and that Complainant's monthly budget amount will be \$275.00, beginning with Complainant's September 2014 due date. Complainant and Respondent further agree that Complainant will pay his monthly budget bill plus \$125.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's September 2014 due date. Complainant and Respondent further agree that


Complainant's monthly budget amount may adjust quarterly to reflect Complainant's actual electric usage.
