Dear Secretary Rich:

This responds to your letter of October 20, 1988 dismissing the application of R.P. Blair Equipment Rentals, Inc. at A-107697 for Blair's failure to file evidence of public liability/property damage and cargo insurance coverage.

We have contacted James McCarthy of the Commission's insurance section to discuss Blair's insurance filings. Mr. McCarthy advised that Blair has the required evidence of public liability/property damage insurance coverage on file with the Commission but that no cargo insurance filing has been made.

The service to be rendered by Blair pursuant to the authority obtained in this proceeding will consist entirely of the transportation of shipments in dump trucks and having a value of five hundred dollars (\$500.00) or less. Consequently, cargo insurance is not required. 52 Pa. Code §32.13(b).

Although aware that cargo insurance was not required, Rubin P. Blair, President of R.P. Blair Equipment Rentals, Inc., was unaware of the Commission's requirement that a cargo insurance waiver form need be filed in order to achieve compliance with the Commission's regulations. Consequently, the required waiver form was not timely filed.

Enclosed herewith is a cargo insurance waiver form that has been properly executed by Mr. Blair. This is to respectfully request that the Commission re-open this proceeding and allow the late-filing of the enclosed waiver form.

EXEMPTION FROM P.U.C. CARGO INSURANCE REGULATIONS

This is to advise that R. P. Blair Equipment Rentals, Inc.
