**RESPONDENT, PECO ENERGY COMPANY'S
MOTION FOR JUDGMENT ON THE PLEADINGS**

Respondent, PECO Energy Company (“PECO Energy”), pursuant to 52 Pa. Code § 5.102(a) respectfully petitions this Honorable Commission to dismiss the instant Complaint for the following reasons:

I. PROCEDURAL HISTORY:

1. On or about June 6, 2014, Complainant, Adventure Alley CLC, LLC filed a Formal Complaint with the Pennsylvania Public Utility Commission (“PUC”).
2. On July 8, 2014, PECO Energy was served the above-mentioned Formal Complaint. A copy of Complainant’s Formal Complaint is attached hereto as (Exhibit 1).
3. On July 22, 2014, PECO Energy filed an Answer & New Matter to the Formal Complaint. A copy of PECO Energy’s Answer & New Matter is attached hereto as (Exhibit 2).
4. Pursuant to 52 Pa. Code § 5.63, Complainant had twenty days from the filing date of PECO’s New Matter on July 22, 2014, to respond.

5. To date, over twenty (20) days have passed since PECO filed its New Matter on July 22, 2014. As Complainant has failed to timely respond to the New Matter, PECO is filing this Motion seeking Judgment on the Pleadings.

II. RELEVANT FACTS:

6. In its Complaint, the Complainant alleges that it operates a business (Adventure Alley CLC, LLC) at 903-905 Tyson Avenue Philadelphia, PA 19111.

7. The Complainant alleges that it has an account with PECO Energy for electric service under account number 41600-98013.

8. The Complainant alleges that Great American Power (“Great American”) is their commercial electric supplier.

9. The Complainant alleges that Great American increased their rates and never notified them of a rate increase.

10. The Complainant alleges that their bill is four times higher than what they have been paying for years.

11. PECO Energy additionally avers that PECO Energy is not a proper party to this formal complaint as Great American is not the same company as PECO Energy. PECO Energy is not a party to the contract between the Complainant and Great American, and does not have control over Great American’s rates.

III. LEGAL ARGUMENT

A. Standard of Review

12. The Commission's regulations at 52 Pa. Code §5.102(a) permits any party to move for summary judgment or judgment on the pleadings after the pleadings are closed, but within such time as to not delay a hearing.

13. Under 52 Pa. Code §5.102(d)(1), the presiding officer will grant the motion if the pleadings, depositions, answers to interrogatories, admissions and affidavits show that there is no genuine issue as to a material fact and that the moving party is entitled to judgment as a matter of law.

14. The moving party bears the burden of showing that no genuine issue of material fact exists and that it is entitled to judgment as a matter of law. The Commission must view the record in the light most favorable to the non-moving party, giving that party the benefit of all reasonable inferences. First Mortgage Co. of Pennsylvania v. McCall, 459 A.2d 406 (Pa. Super. 1983).

15. The provision at 52 Pa. Code §5.102(c) serves judicial economy by avoiding a hearing where no factual dispute exists. If no factual issue pertinent to the resolution of the case exists, a hearing is unnecessary. Lehigh Valley Power Committee v. Pennsylvania Public Utility Commission, 563 A.2d. 557 (Pa. Cmwlt. 1989).

B. The Complainant's Complaint should be dismissed because Adventure Alley CLC, LLC is a commercial customer; and the Complainant is required to be represented by counsel.

16. The Complainant, Adventure Alley CLC, LLC, is a commercial customer operating a business at the service address at issue. See Pennsylvania Department of State Corporate Search, attached hereto as (Exhibit 3).

17. Adventure Alley CLC, LLC was incorporated in the Commonwealth of Pennsylvania on November 27, 2006. See Pennsylvania Department of State Corporation Search, attached hereto as (Exhibit 3).

18. The principal address listed for Adventure Alley CLC, LLC with the Pennsylvania Department of State is the service address of 903-05 Tyson Avenue Philadelphia, PA 19111. See (Exhibit 3).

19. As a commercial customer and corporation, Complainant is required to be represented by counsel in adversarial proceedings before the Commission.

20. The proceedings become adversarial at the time when respondent files an Answer. A Complaint filed by a corporation will be dismissed for failure to be represented by an attorney in an adversarial proceeding. 52 Pa. Code §1.8; 1.21-§ 1.23; In Re: Checker Cab, 49 Pa. PUC 159, 160 (1975), Moore v. I. Berman and Cross, Inc., Pa. PUC 427, 428 (1975).

21. On July 22, 2014, PECO Energy filed an Answer with New Matter to the Complainant's Complaint. See (Exhibit 2).

22. Once PECO Energy filed the Answer with New Matter the current PUC matter became adversarial. See 52 Pa. Code §1.8; 1.21-§ 1.23; In Re: Checker Cab, 49 Pa. PUC 159, 160 (1975), Moore v. I. Berman and Cross, Inc.

23. To date, the Complainant Corporation has not had counsel enter an appearance for this matter.

24. Accordingly, PECO Energy requests that the Commission dismiss the Complainant's Complaint for failure to be represented by counsel.

IV. CONCLUSION

25. PECO Energy has not been served with a response to its New Matter, and therefore it requests that the facts stated therein be deemed admitted. 52 Pa.Code §5.63(b) (providing that facts in new matter may be deemed admitted if there is no reply).

26. The Complainant has had no attorney enter an appearance; and therefore, the Complaint should be dismissed.

WHEREFORE, PECO Energy Company respectfully requests that your Honorable Commission dismiss the Complainant's Complaint.

In addition, the PUC generally does not handle complaints about cell phone or Internet service, but may be able to resolve a dispute regarding voice communications over the Internet (including the inability to make voice 911/E911 emergency calls) or concerns about high-speed access to Internet service.

5. Requested Relief

I Think we should've^{been} notified about the rate changing to a ridiculous rate. We have the option to go back to Peco if we wanted too and we would've if we would've known the rate increased. We have been paying the same amount at different times of the year and that should't have changed for the worse. Great American solicited us with cheaper rates NOT higher ones.

Note: The PUC can decide that a customer was not billed correctly and can order billing refunds. The PUC can also fine a utility or company for not following rules and can order a utility or company to correct a problem with your service. Under state law, the PUC cannot decide whether a utility or company should pay customers for loss or damages. Damage claims may be sought in an appropriate civil court.

6. Protection from Abuse

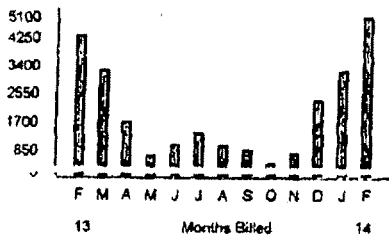


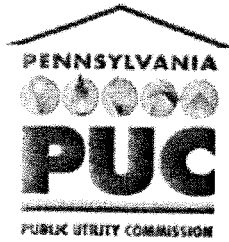

ANSWER OF RESPONDENT,
PECO ENERGY COMPANY

On July 8, 2014, PECO Energy Company ("PECO Energy") was served with a formal complaint filed by Adventure Alley CLC, LLC. (hereafter "Complainant") in the above captioned docket. Pursuant to 52 Pa. Code § 5.61, PECO responds to the Complaint and states:

1. Admitted.
2. Admitted.
3. Admitted.
4. Unless specifically admitted herein, PECO Energy denies all material allegations of fact and conclusions of law in the instant complaint.

In their Formal Complaint, Complainant alleges that Great American Power ("Great American") is their commercial electric supplier. They claim that Great American increased their rates and never notified them of a rate increase. The Complainant alleges that their bill is four times higher than what they have been paying for years. PECO Energy avers that the Complainant chose Great American as their supplier. PECO Energy additionally avers that PECO Energy is not a proper party to this formal complaint as Great American is not the same

company as PECO Energy and PECO Energy is not a party to the contract between the Complainant and Great American. Further PECO Energy does not have control over Great American's rates.

Preliminarily, PECO Energy avers that the Complainant is a commercial customer operating a business at the premises. The Complainant is a Limited Liability Corporation registered with the Pennsylvania Department of State Bureau of Corporations. See Complainant's corporate fictitious name registration with the Pennsylvania Department of State, attached hereto as Exhibit "1". As a commercial customer, Complainant is required to be represented by counsel in adversarial proceedings before the Commission.¹

Complainant established an account for commercial electric service at 905 Tyson Avenue, Philadelphia, PA 19111 under account number 41600-98013 on January 17, 2008. See Account Activity Statement, attached hereto as Exhibit "2". On February 28, 2013, PECO Energy received a request from the Complainant to switch to Great American. The Complainant switched to Great American as their electric supplier effective March 21, 2013. The Complainant remained enrolled with Great American until the company received a request on March 7, 2014 from the Complainant to switch back to PECO Energy. Supplier billing with Great American ended effective March 21, 2014.

Section 5.4.1 of PECO Energy's Gas Supplier tariff:

EGSs shall be solely responsible for having appropriate contractual or other arrangements with their Customers necessary to implement Direct Access consistent with all applicable laws, PAPUC requirements, and this Tariff. The Company shall not be responsible

for monitoring, reviewing or enforcing such contracts or arrangements.

See Section 5.4.1 of PECO's Electric Supplier Tariff, attached hereto as Exhibit "3".

In this case, the Complainant disputes the rates charged by their electric supplier Great American. PECO Energy is not a party to the contract between the Complainant and Great American. PECO has no knowledge of the contract and rate agreement the Complainant entered into with Great American and has no visibility into that agreement. Accordingly, the Complainant's formal complaint raising this issue is improperly placed against PECO Energy and should be filed against the supplier Great American only. Consistent with Section 5.4.1 of the tariff, PECO Energy is not the supplier and is not responsible Great American's rates.

8. Denied. PECO is without knowledge or information sufficient to form a belief as to the truth of this averment and, therefore, such allegation is deemed denied.

WHEREFORE, PECO Energy Company respectfully requests that your Honorable Commission establish a date certain by which Complainant is required to have an attorney enter an appearance in this matter. Additionally, the complaint should be dismissed because Complainant is not legally entitled to relief requested.

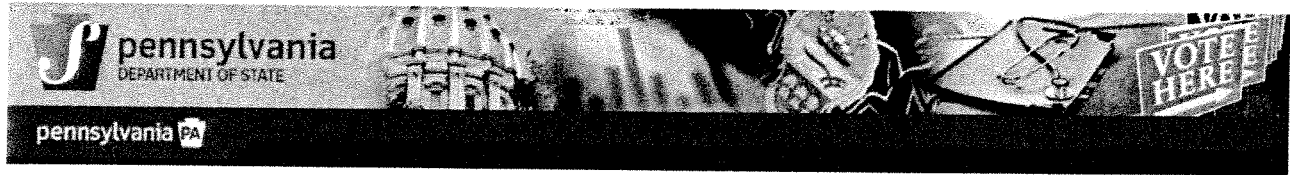

5.4 Provisions relating to an EGS's Customers.

5.4.1 Arrangements with EGS Customers. EGSs shall be solely responsible for having appropriate contractual or other arrangements with their Customers necessary to implement Direct Access consistent with all applicable laws, PaPUC requirements, and this Tariff. The Company shall not be responsible for monitoring, reviewing or enforcing such contracts or arrangements.

5.4.2 Transfer of Cost Obligations Between EGSs and Customers. Nothing in this Tariff is intended to prevent an EGS and a Customer from agreeing to reallocate between them any charges that this Tariff imposes on the EGS, provided that any such agreement shall not change in any way the EGS's obligation to pay such charges to the Company, and that any such agreement shall not limit the right of the Company to seek recourse directly from the EGS's Customer for any charges owed to the Company by the EGS Customer or preclude the termination or reconnection of the EGS Customer by the Company as provided in the Company's tariffs.

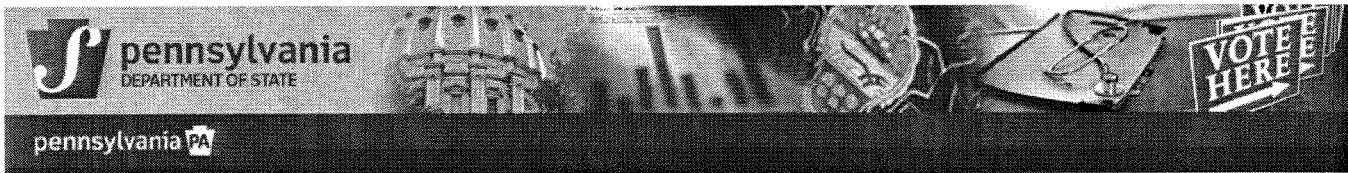

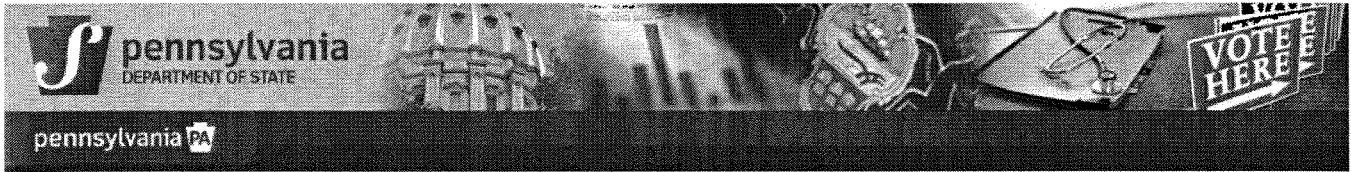
